Client agrees to use the venue's, or personal liability insurance coverage during the event for any liability claim related to photobooth and indemnify PBSB. Should PBSB fail to provide a fully operational Photobooth during the above agreed times, the client's only remedy is a full refund of all money paid. PBSB is not responsible for any consequential damages or lost opportunities upon breach of this agreement. If partial performance has occurred, the client may accept the Scrapbook upon agreement to pay a prorated amount of the original contracted price. Any dispute related to this agreement will be settled by voluntary mediation. If mediation is unsuccessful, the dispute will be settled by binding arbitration using an arbitrator of the American Arbitration Association in Arizona. The laws of the State of Arizona govern this agreement. The parties agree that this Agreement is the entire agreement between them. This Agreement binds and benefits both PBSB and Client and any successors.
